And today's financial tip:

What does an All-Or-None order mean?

An All-Or-None order is a limit price order which is to be executed in its entirety or not at all. For example an investor places an all-or-none order to buy 1,000 TDC shares at \$4.00, but only 600 TDC shares are offered for sale at \$4.00. Even though the prices match no trade will occur because the sell order is not large enough to fill the quantity required by the all-or-none buy order.
