Summary trading report for the week ending Friday, 17 January 2014

Eastern Caribbean Securities Market

On the Eastern Caribbean Securities Market this week the following securities traded:

- 90 East Caribbean Financial Holding Co Ltd shares traded at \$7.36 per share,
- 2,500 St Kitts Nevis Anguilla National Bank Ltd shares traded at \$2.20 per share,
- 2,015 TDC shares traded at \$1.49 per share,
- 2,000 TDC shares and 1,000 St Kitts Nevis Anguilla National Bank Ltd shares crossed the market.

Regional Government Securities Market (RGSM)

On the Regional Government Securities Market, the Government of Grenada's 91-day Treasury bill auctioned on the ECSE's primary market platform raised \$20.0 million. The competitive uniform price methodology used, resulted in a discount rate of 5.0%.

The next auction on the Regional Government Securities Market will be that of the Government of Saint Lucia's 180-day Treasury bill, which will take place on 20 January 2014 using the primary market platform of the Eastern Caribbean Securities Exchange. Bidding for this auction commences at 9:00 am and ends at 12:00 pm.
