# Job Summary:

The primary responsibility of the IT Officer is to perform IT application support and network administration of the ECSE and its subsidiary, the ECCSD.

# **Responsibilities:**

The basic responsibilities of this position include to:

- Administer and maintain SQL Server databases and backup systems.
- Liaise with end users to identify modifications needed to existing applications and where necessary assess and recommend new applications to meet user requirements
- Assist with the development of system designs and application specification using industry best practices.
- Assist with the configuration, administration and maintenance of network equipment and virtualized server environments.
- Install, maintain and upgrade computer equipment, systems and applications and provide timely helpdesk support for end users.
- Administer network and data security policies, including directory, group policy, firewalls, end point protection, email security and intrusion detection and prevention and recommend changes where necessary to network and data security policies.
- Draft or update technical policies and procedures for all IT systems, tasks and in-house built applications including user guides and system manuals.
- Deliver training to end users on the use of new or existing systems or applications.
- Liaise with vendors to ensure timely service delivery and ensure that contractual obligations and terms of SLAs are met.
